

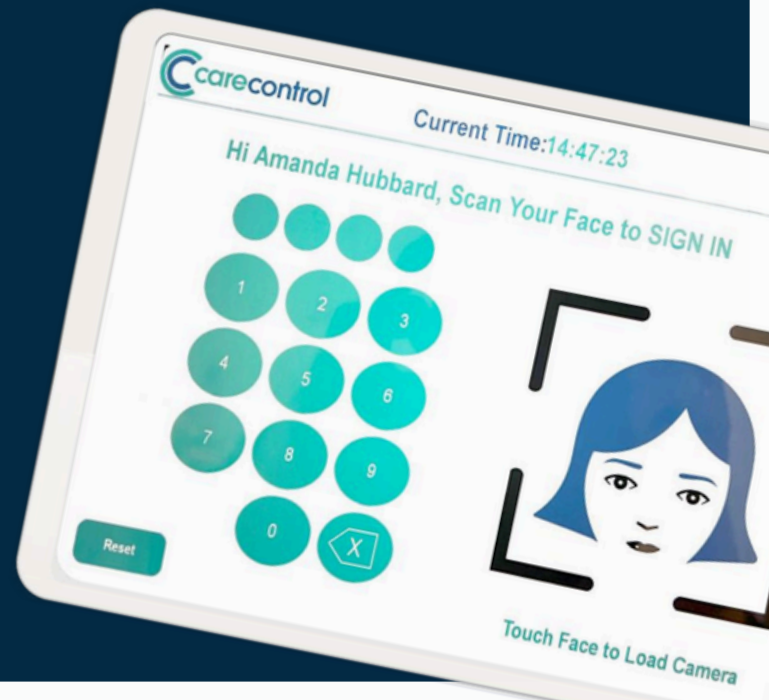

Tablets

Setting up on the wall – Installation Considerations

✔ Mount the Device Holders on a flat Wall

✔ Check you have power supply to charge the 2 tablets

✔ Set the 2 tablets at different heights to suit peoples heights

✔ Recommend Optimum Heights for each device of 165cm and 155cm measuring from the floor to Top of the Device.

✔ Consider if you want the Tablet to be removeable or locked in the wall Holder

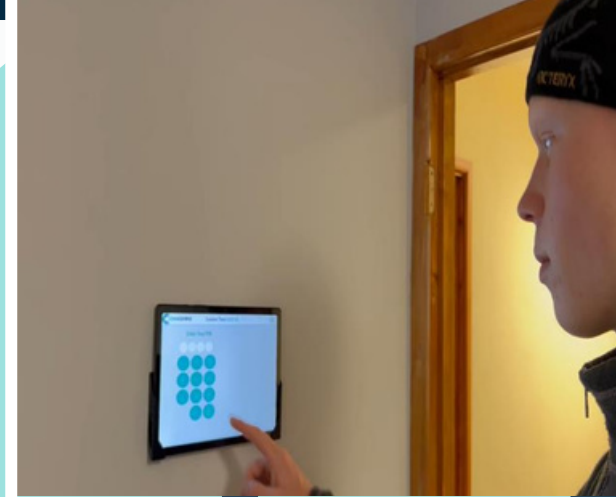

Simple Steps to signing in on Care Control Mobile

- Enter your Care Control PIN Number
- Touch on the face icon to load the camera
- Wait a few seconds for the camera to match your facial profile

- You have now signed in

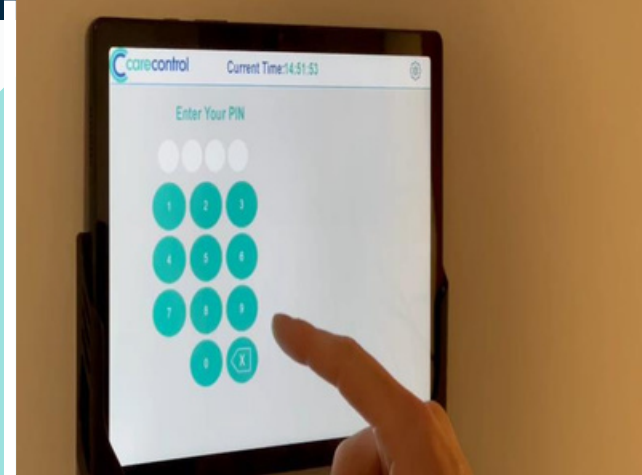

Simple Steps to signing out on Care Control Mobile

- Enter your Care Control PIN Number

- You have now signed in

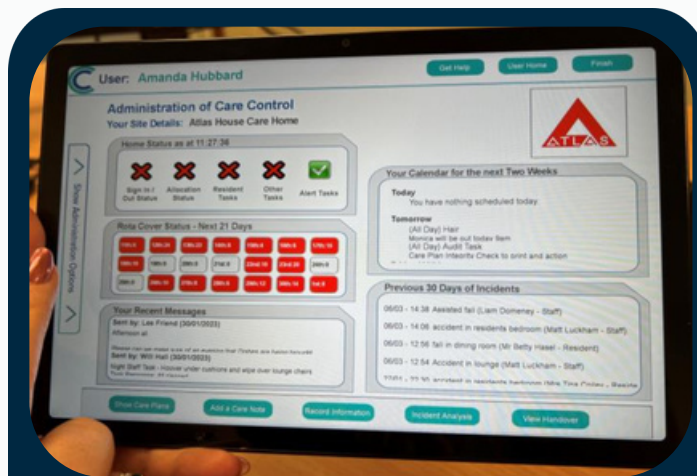

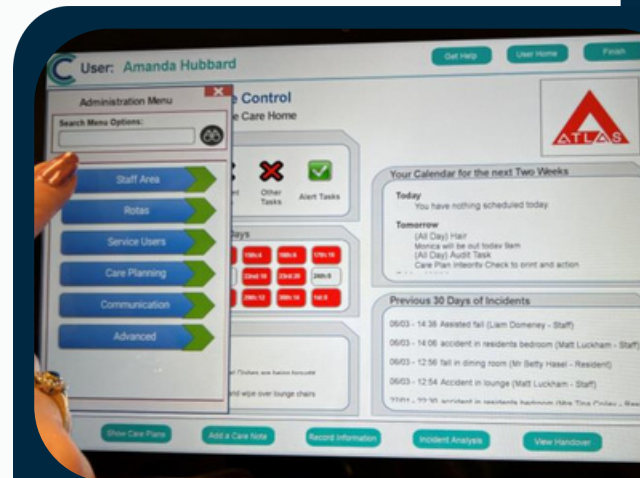

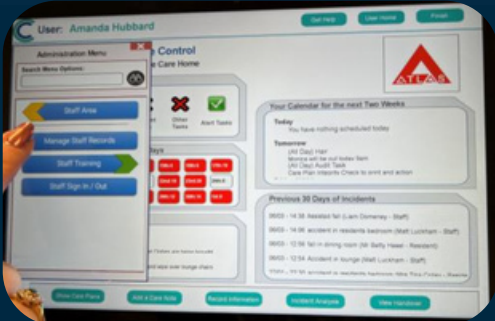
Step 1

Click Left Tab to open Show Administration Options.



Step 2

Click on Staff Area.



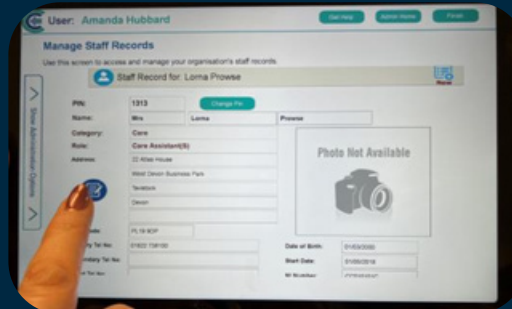
Step 3

Click on Manage Staff Records.



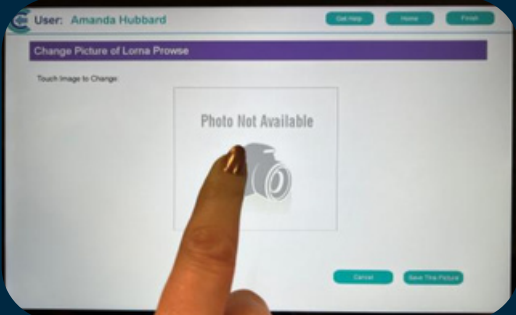
Step 4

Select Staff members name.



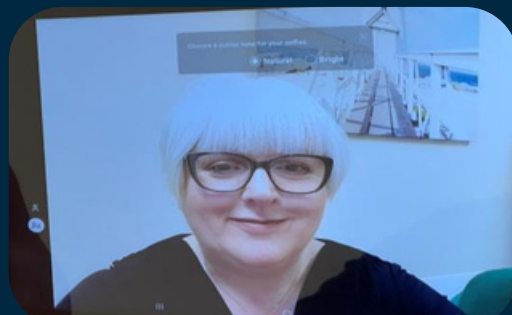
Step 5

Click on Blue Page/Pen Icon, then change icon beside the photo camera.

Step 7

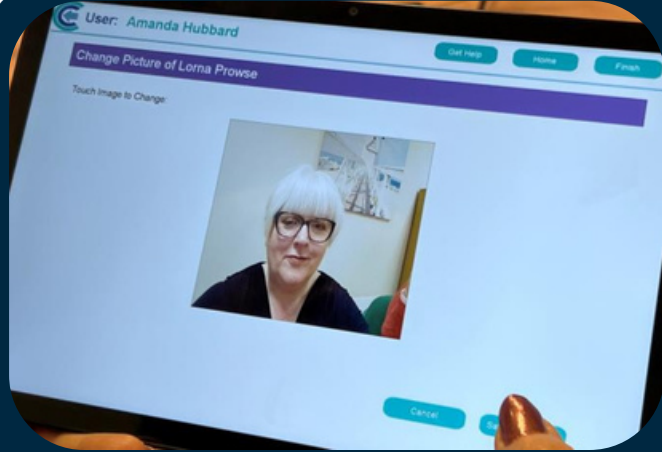
Ensure the facial photo is close up and head on.

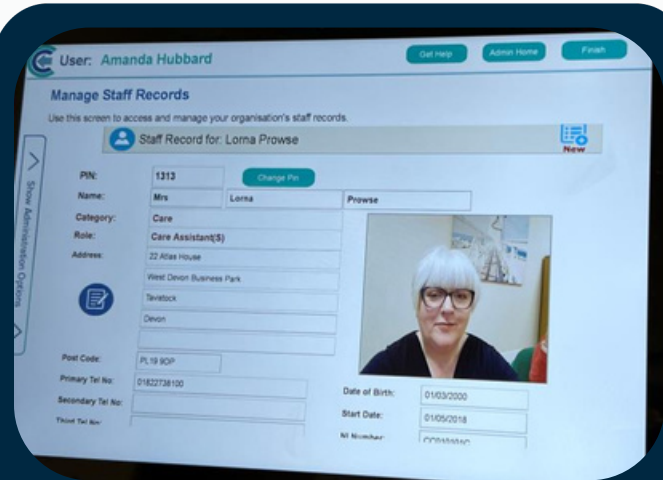
Add staff image onto Care Control Systems

Profile Pictures

Facial Recognition

For the best results

- Facial Profile picture must be taken close up.
- Use the facial frame to capture the face entirely.
- Check if the User wears glasses regularly.
- Note Facial recognition compares to the profile picture on file, if glasses were removed during the profile picture setup then worn on sign in/out it will cause a mis-match unfound face error.

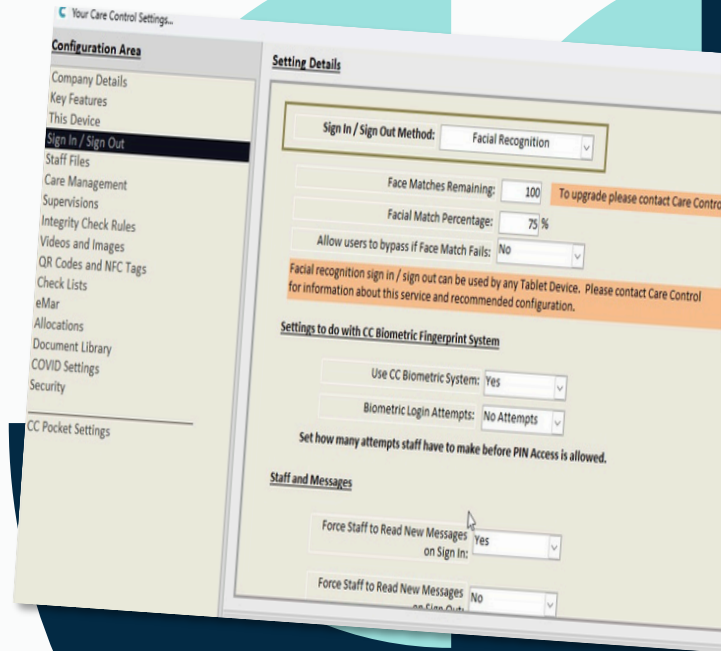
Let's Talk Facial Licences



- Initial setup provides one off Setup cost £140+ VAT and will provide 12,000 facial recognition matches

How licences work

- One licence is one face matched photo.
- Each Sign in or out uses one Licence.
- To calculate how many matches you'd use please calculate number of staff working per day, multiple by 2;
- For example –A Care Home with 46 Staff, any given day 12 staff would be working in a 24 hour period, uses 24 matches per day. 168 per week, 672 per month.
- A match is used if you have a face on file, it is not used if you don't have a picture on file to match against.



Let's Talk Facial Licenses

Configuration

Recommended Configurations

- Face matches remaining = Number of picture matches left to use.
- Facial Match Percentage = Accuracy of match compared to the staff members profile picture. You can adjust the percentage control.

We recommend 75% accuracy.

- Allow users to bypass if Face Match fails = Yes/No

We recommend No in order the Staff member is forced to sign in or report unable to do so to a Manager.

- Turn off CC Bio Metrics fingerprint to "No"
- Staff & Messages remain unchanged

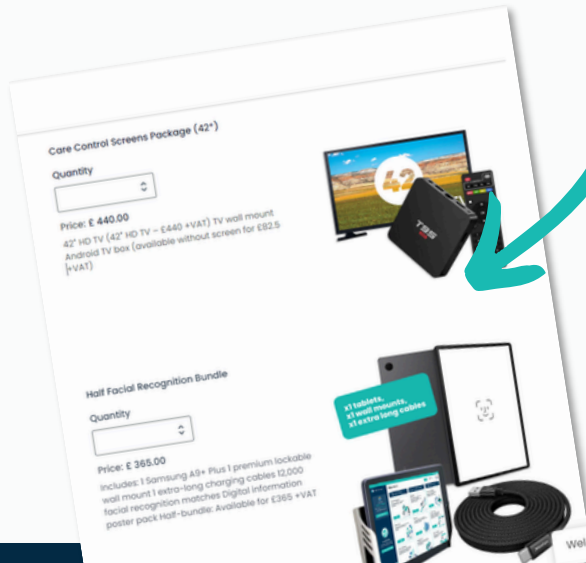

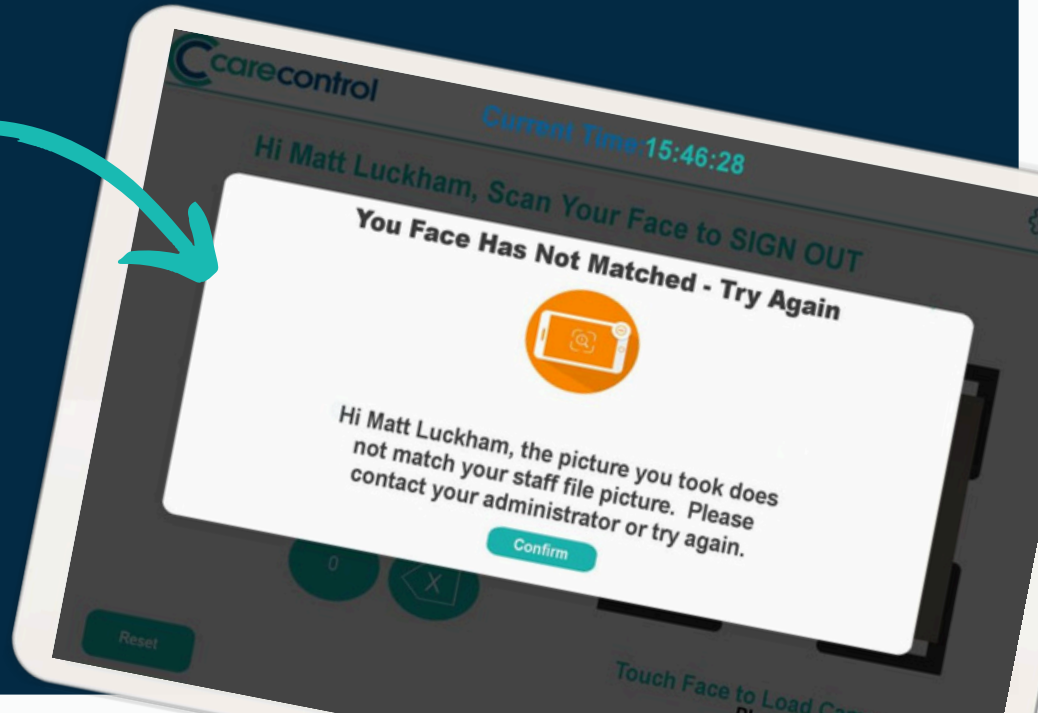


Basic troubleshooting

If a facial profile picture is not recognised, e.g. User wearing glasses not worn during registered profile picture. The system will display this message.

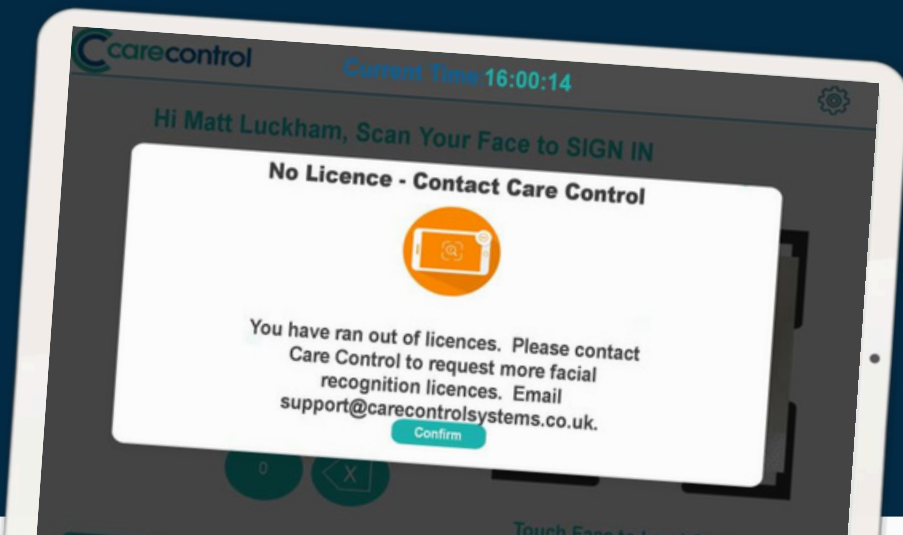
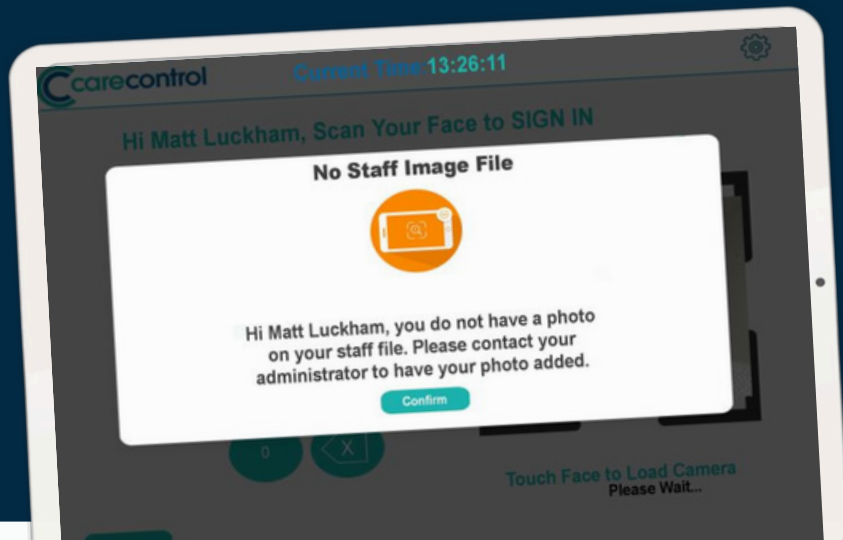


Troubleshooting continued
